RESOLUTION NO. 50

WHEREAS, be it known that Mr. Isaac T. Conui, former Sanitary Inspector of the Municipality of Ormoc, now Ormoc City, has applied for retirement under RA No. 660, as amended;

WHEREAS, the Assistant General Manager of the Government Service Insurance System, Manila, in his letter addressed to the City Council, thru the City Mayor, this City, dated January 28, 1955, informed this Body, that the services of Mr. Isaac T. Conui for the period from January 16, 1910 to December 31, 1934 were not covered by official records but were only supported by sworn affidavits of the applicant, and Messrs. Eutiquiano Fiel and Casiano Puray;

WHEREAS, in compliance with the 2nd paragraph of the letter above cited, this Body conducted a thorough investigation, to determine whether or not the services claimed by Mr. Isaac T. Conui from January 16, 1910 to December 31, 1934 have been rendered;

WHEREAS, after the investigation had been conducted this Body found out that Mr. Isaac T. Conui rendered continuous services from January 16, 1910 to December 31, 1934 as such Sanitary Inspector of the then Municipality of Ormoc (now Ormoc City);

WHEREAS, the Hon. Members of the Board unanimously agreed to recognize the services of Mr. Isaac T. Conui and to credit him with such services rendered from January 16, 1910 to December 31, 1934; and that all premiums due him for his services be credited in his favor; and

WHEREAS, in view of the services rendered by Mr. Isaac T. Conui for the period above-stated this Body is willing to pay to the Government Service Insurance System the premiums corresponding to such period;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Porfirio Ayuyao;

BE IT RESOLVED, as is hereby resolved, to recognize the services of Mr. Isaac T. Conui and to credit him with such services rendered from January 16, 1910 to December 31, 1934;
