RESOLUTION NO. 52

WHEREAS, be it known that the residents of the barrio of Canadieng, Ormoc City, represented by the barrio lieutenant and PTA President and the Vice President, petitioned this Body that the school authorities of the City be requested to continue the existence of the complete elementary classes in said barrio; they (residents) having been reliably informed - as stated in their petition - that Mr. Leonardo L. Torreses, City Supervisor of Ormoc District I will close the intermediate classes in Canadieng at the end of this school year;

WHEREAS, it was further stated in the petition that Canadieng has many intermediate pupils attending grades V and VI every school year numbering even more than the required class load allotted to barrios;

WHEREAS, it was furthermore stated in said petition that Canadieng is more or less one and one-half kilometers away from the City Central School and it will be very risky for the school children of said barrio to attend classes in said school due to the many motor vehicles passing on the road leading to the Central School;

WHEREAS, for reasons stated above, the residents of barrio Canadieng requested for the continuance of the opening of the intermediate classes in said barrio;

NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to request the school authorities of Ormoc City that in case any intermediate class will be closed, that intermediate class will only be closed after consultation of this Board;

BE IT RESOLVED FURTHER, that in the assignment of City intermediate classes for the next school year, there should be consultation of this Board and the opening of new classes or closing the existing ones must be with the knowledge of this Board;


BE IT RESOLVED FINALLY, to furnish copy of this resolution each to the Div. Supt. of Schools, Tacloban City; the Dist. Supervisor, Dist. I, Ormoc City; the Hon. City Mayor; City Treasurer; City Auditor; (the barrio lieutenant; of Canadieng) all of Ormoc City.
