Letter of Mrs. Pepita S. Boyer, City Principal,
City Central School, Ormoc City, dated November 4,
1954 hereunder quoted verbatim as follows:

Honorable Gentlemen:

I have the honor to request that honorable body to appropriate the amount of ₱480.00 representing the city's counterpart of my salary for services rendered as city principal, this city, for the following period: January 1, 1954 to June 30, 1954.

For your information, I could not draw that amount from this city's funds because I was then receiving my salary in full from national-insular funds which was erroneous according to recent information received by the undersigned from the Office of the Budget Commission. According to said information, I should have drawn half of my salary (₱80 a month) from city funds. Unfortunately, said information reached me late so that when the city budget for this fiscal year was being prepared the above-stated amount could not be included as an outstanding obligation of the city to the undersigned. Hence, the above request.
