RESOLUTION NO. 64

WHEREAS, the market place in Valencia is very insa-  
nitary as there is no appropriate place for that purpose  
and ~~app~~ appropriate building;

WHEREAS, the same is true with the barrio of Ipil  
and both of these big barrios are in need of an appropriate  
market place;

WHEREAS, a market for these barrios will increase the  
revenue of the City of Ormoc;

WHEREAS, there is a letter of the City Health Officer  
recommending the construction of markets for these barrios;

NOW THEREFORE, the Board, on motion of Councilor  
Usualdo F. Laguitan, seconded by Councilor Guillermo T.  
Parrilla;

BE IT RESOLVED, as is hereby resolved, to construct  
market buildings for barrios Valencia and Ipil, Ormoc  
City. The barrio lieutenants of these barrios with the  
respective inhabitants will recommend the site and to make  
temporary agreement with the owners for the lease of the  
sites selected either by donation or by purchase and re-  
port the same to this Body;

BE IT FURTHER RESOLVED, to request the City Engineer  
and the City Health Officer to plan and design a market  
suitable for these barrios and to recommend same to this  
Body for approval and to locate funds for same;


RESOLVED FINALLY, to furnish copy of this resolution  
each to the Hon. City Mayor; City Treasurer; City Auditor;  
City Health Officer; City Engineer; and the barrio lieute-  
nants of Valencia and Ipil, all of Ormoc City.
