Thru oversight, the bookkeeper failed to take in the account (account payable) the amount of \$\mathbb{P}49.78 and therefore, the amount was not remitted to the Government Service Insurance System.

In view of this, it is requested that authority be given to effect that the amount of \$\mathbb{P}49.78\$ be paid from the current appropriation of salary of intermediate teachers, Mr. Congson being an intermediate teacher.
