WHEREAS, be it known that there is pending approval in the House of Representatives, Congress of the Philippines, House No. 4087, introduced by Congressman Cabangbang Rodriguez Jr., Cruz (E.R.), Abeleda, Ganzon, Niguid, Veloso, (I.L.) and Fornier, entitled, "An Act exempting Carabaos Unfit For Work From The Slaughter Ban Prescribed by Executive Order Numbered Eighty-eight, Dated January Six Nineteen Hundred And Fifty-five, And Creating A Municipal Carabao Slaughter Board In Each Municipality";

WHEREAS, Councilor Esteban C. Conejos suggested to the Honorable Members of the Board to strongly indorse House No. 4087;

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Jorge S. Tan;

BE IT RESOLVED, as is hereby resolved, to strongly indorse House No. 4087 above cited, requesting Congressman Cabangbang that in the City of Ormoc, a meat inspector instead of the Principal Teacher be designated as one of the Members of the Municipal Carabao Slaughter Board and that the law as approved should be certified by the President of the Philippines in special sessions;


