RESOLUTION NO. 76

WHEREAS, be it know that Mr. Cenon E. Alao, Asst. District Land Officer, Land District Office No. 12, Bureau of Lands, Tacloban City, in his letter dated May 6, 1955, requested information from this Body as to the nature of improvement of the City Government desires to use lot numbered 2255 of Ormoc Cadastre, as contemplated in resolution numbered 86, s. 1951 of this Body, so that proper recommendation could be made for the reservation of subject portion of said lot;

WHEREAS, Councilor Esteban C. Conejos manifested that lot numbered 2255 of Ormoc Cadastre, except the 15 meters extension towards the Anilao River, as cited in resolution numbered 86, s. 1951 of this Body, giving to applicants Dr. Cesar Samson; Mr. Usualdo F. Laguitan and Mrs. Visitacion P. Aguirre, and those portions actually occupied by private houses, be reserved for public playground;


NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Cleto P. Evangelista;

BE IT RESOLVED, as is hereby resolved, that lot numbered 2255 of Ormoc Cadastre, except the 15 meters extension towards the Anilao River, as cited in Resolution numbered 86, s. 1951 of this Body, giving to applicants Dr. Cesar Samson, Mr. Usualdo F. Laguitan and Mrs. Visitacion P. Aguirre and those actually occupied portions by private houses be reserved for public playground;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor, City Treasurer, City Auditor, all of Ormoc City; and the Asst. District Land Officer, Land District No. 12, Tacloban City;

CARRIED. Councilor Usualdo F. Laguitan against.


