RESOLUTION NO. 24

WHEREAS, be it known that this body enacted an ordinance charging inspection fees for large cattle and pigs ship out of Ormoc City - Ordinance No. V, series of 1954;

WHEREAS, said ordinance was declared null and void by the Hon. Executive Secretary, Malacañang, Manila, in his letter dated May 24, 1955 for reasons stated therein;

WHEREAS, because of the enforcement of said ordinance prior to its disapproval, Mr. Antonio Fernandez, of Ormoc City, who is a merchant, had paid to the City Treasurer of Ormoc City certain amounts as inspection fees of pigs he shipped from Ormoc to Manila;

WHEREAS, Councilor Esteban C. Conejos expressed opinion that the decision of the Executive Secretary in connection with said Ordinance No. V, s. 1954 of this body is apparently inconsistent; and

WHEREAS, Councilor Esteban C. Conejos suggested to the members of the Board present to request the City Treasurer of Ormoc City not to refund Mr. Antonio Fernandez the amount he has paid to the City for pigs shipped from Ormoc to Manila, until Ordinance No. V, s. 1954 of this Body is declared null and void by the Court;

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to request the City Treasurer, Ormoc City, not to refund Mr. Antonio Fernandez the amount he has paid to the City for pigs shipped from Ormoc to Manila, until Ordinance No. V, s. 1954 of this Body is declared null and void by the Court;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor; City Treasurer; City Auditor; and Mr. Antonio Fernandez, all of Ormoc City.




