WHEREAS, be it known that Mr. Ramon Bantasan, Secretary to the Municipal Board, this City, has unpaid salary differentials in the total amount of NINE HUNDRED EIGHTY-ONE PESOS AND NINETY-ONE CENTAVAS (P981.91) - at the rate of P50.00 per month from July 1, 1952 to October 17, 1953 and at P10.00 per month from October 18, 1953 to June 30, 1955;

WHEREAS, Mr. Ramon Bantasan made representations before this body that he is in dire need of money at present for the expenses of his son who is studying in Manila;

WHEREAS, Councilor Usualdo F. Laguitan suggested to the Hon. Members of the Board to authorize the payment of P500.00 to Mr. Ramon Bantasan as partial pay for his salary differentials the same amount to be taken from the salary savings of the Municipal Board (per diems) and savings of other departments;


NOW THEREFORE, the Board, on motion of Councilor Usualdo F. Laguitan, seconded by Councilor Cleto P. Evangelista;


