RESOLUTION NO. 102

WHEREAS, the purpose of the distribution of radio receivers is to keep the people well-informed on events, local and international; to acquaint them especially those in the rural areas of the functions, activities and accomplishments of the government and to ultimately bring the government closer to the people and the people closer to the government;

WHEREAS, it is the desire of this body to avail of the radio receivers being distributed by the government for the good of the people of this City;

NOW THEREFORE, the Board, on motion of Councilor Porfirio Ayuyao, seconded by Councilors Alvaro I. Gutierrez and Teotimo Ocubillo;

BESIT RESOLVED, as is hereby resolved, to respectfully request the Radio Control Board, Department of Public Works & Communications, to allot one (1) radio receiver to this City for the use of the following barrio:


1. Catayum, Ormoc City

RESOLVED FURTHER, that this City accepts all the conditions stipulated in Department Order No. 1, dated December 1, 1947 of the Department of Commerce and Industry, which is still enforced, and declares that it will defray the expenses for the installation, operation maintenance and repair of the sets applied for;




