RESOLUTION NO. 103

WHEREAS, it is the desire of this body to avail of the radio receivers being distributed by the government for the good of the people of this City;

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Alvaro I. Gutierrez;

BE IT RESOLVED, as is hereby resolved, to respectfully requests the Radio Control Board, Department of Public Works and Communications, to allot FIFTEEN (15) radio receivers to this City for the use of the following barrios:




