RESOLUTION NO. 106

WHEREAS, we have noted that an amount of five million pesos has been authorized by the President to be negotiated by the NARIC from the RFC as a loan for the construction of bodegas and rice driers in Cotabato and other rice producing areas of the Philippines;

WHEREAS, there is now an agency of the NARIC in Ormoc City that is already functioning to the advantage of the population of this City and the western coast of the province of Leyte but will be very much handicapped in the future due to the absence of a warehouse and a rice drier. (Rice is being harvested at times during rainy season)

WHEREAS, the harvesting season is fast approaching and that the NARIC Agency will need such bodega and rice drier to effectively stabilize the price of palay and corn in this area by buying the produce of the farmers at floor price fixed by the government;

NOW, THEREFORE, the Board, on motion of Councilor Usualde F. Laguitan, seconded by Councilor Teetime P. Ocubille;

BE IT RESOLVED, as is hereby resolved, to petition the President of the Philippines and Hon. Juan O. Chieco, Chairman and General Manager of the NARIC to appropriate out of the five million pesos sufficient amount to construct a warehouse for the NARIC and a rice drier at the City of Ormoc;

RESOLVED FURTHER, to furnish copy of this resolution (each) to Atty. Sergio Denoga, In-Charge of the NARIC Agency, Ormoc City, requesting him to make the necessary representation to the Chairman and General Manager of the NARIC and the President of the Philippines towards the construction of a NARIC warehouse and rice drier at Ormoc City;

RESOLVED FINALLY, to furnish copy of this resolution each to the Hon. City Mayor, City Treasurer, City Auditor and City Engineer, all of Ormoc City.
