RESOLUTION NO. 140

DESIGNATING THE CITY ROADS AND BRIDGES ACTUALLY
SERVICING MOTOR VEHICULAR TRAFFIC UPON WHICH THE
NATIONAL AID FOR MAINTENANCE SHALL BE SPENT

WHEREAS, in compliance with Sec. 9(b) of R.A. No. 917, this Body, in session assembled, hereby resolved to designate, as it hereby designates, the streets and bridges listed hereunder as the ones on which the National Aid to this city from the Highways Special Fund for the maintenance of existing and unabandoned city roads and bridges, plus the counterpart maintenance fund appropriated by this body for said purpose, shall be spent:

5. Mabini-Macabug Road.....	3.500 kms.
6. Valencia-Maticaa Road.....	3.500 kms.
7. Lilo-an-Lao	1.538 kms.
8. Ormoc-Donghol Road.....	1.280 kms.
9. Catayum-Gatmon	0.550 kms.
10. Ormoc-Patag-Mahayag Road.....	3.00 kms.
11. Ormoc-Naungan Road.....	3.258 kms.
12. All City Streets.....	8.072 kms.
Total.....	49.115 kms.

NOW THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilors Porfirio Ayuyao and Guillermo T. Parrilla;

BE IT RESOLVED, as is hereby resolved, to designate the streets and bridges above listed as the ones on which the National Aid to this city from the Highways Special Fund for the maintenance of existing and unabandoned city roads and bridges, plus the counterpart maintenance fund appropriated by this body for said purpose, shall be spent;

RESOLVED FURTHERMORE, to request, as it is hereby requested, the City Engineer, to prepare an adequate maintenance program for said roads, and an estimate of cost necessary for such maintenance program, forward

the same to the Commissioner of Public Highways for approval and after such approval, submit the same to this Body for the appropriation of the required Counterpart Maintenance Fund.

RESOLVED FINALLY, to furnish copy of this resolution each to the Secretary of Public Works and Communications; the Commissioner of Public Highways; all of Manila; the Hon. City Mayor; City Treasurer; City Auditor and the City Engineer, all of Ormoc City.
