RESOLUTION NO. 141

APPROPRIATING P58,104.00 FOR COUNTERPART MAINTENANCE
FUND FROM THE CITY ROADS AND BRIDGES FUND

WHEREAS, pursuant to Sec. 9(b) Republic Act No. 917,
this Body is required to provide in the annual road and
bridge budget an appropriation for the maintenance of
existing and unabandoned roads, streets and bridges of
this city, actually serving motor vehicular traffic, de-
signated by this Body, equal to at least one-half the
total maintenance requirement, as Counterpart Maintenance
Fund, to be taken from our local Road and Bridge Fund;

WHEREAS, in accordance with the program of work and
estimates prepared by the city engineer and approved by
the Commissioner of Public Highways, submitted to this
body, the total estimated maintenance requirements in this
connection is P58,104.00;

WHEREAS, in order that the national aid from the
highways Special Fund for the maintenance of city roads,
streets and bridges may be released it is required that
the counterpart appropriation from our local funds shall
be certified to by the city treasurer, and made available
for expenditures by the Bureau of Public Highways;

NOW THEREFORE, the Board, on motion of Councilor
Esteban C. Conejos, seconded by Councilors Porfirio Ayuyao
and Guillermo T. Parrilla;


BE IT RESOLVED, as is hereby resolved, that the
amount of P58,104.00 be appropriated by this body from
the roads and Bridges fund as Counterpart Maintenance
Fund Pursuant to Sec. 9(b) of Republic Act No. 917;

RESOLVED FURTHER, to instruct the City Treasurer,
Ormoc City, to prepare the corresponding Roads and
Bridges Fund Budget, and to make the aforestated appro-
priation available for expenditures of the Bureau of
Public Highways, for the purpose hereinbefore mentioned
withdrawable as advance fund by the Disbursing Officers of
said Bureau, duly authorized for this purpose;


RESOLVED FINALLY, to furnish copy of this resolution each to the Accounting Section, Bureau of Public Highways for their information, with the request that the corresponding national aid be promptly released; the Hon. City Mayor; City Treasurer; City Auditor and the City Engineer, all of Ormoc City.


