RESOLUTION NO. 152

WHEREAS, Mrs. Genevera Mercado-Kavanaugh has brought to the attention of the Municipal Board that her land in Valencia, among all others, was bartered with a lot belonging to the Valencia Elementary School;

WHEREAS, Mrs. Kavanaugh has manifested that from the year 1946 up to the present she has not made use of the bartered lot and that no deed of barter and/or exchange was executed in her favor among all others;

WHEREAS, the Board finds it prejudicial to Mrs. Kavanaugh and other private owners of lots affected by the barter and so deems it necessary to create a committee to expedite the issuance of titles to the aforementioned lot owners;

NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilors Alvaro I. Gutierrez and Cleto P. Evangelista;

BE IT RESOLVED, as is hereby resolved, that a Committee be created composed of the following: The City Fiscal as Chairman, and Coun. Porfirio Ayuyao representing this Body, Mr. Roberto B. Paz for the Valencia Community School, and Mr. Andres Garces for the lot owners, all as members;

RESOLVED FURTHER, that the above committee be authorized to work for the lot owners in consideration of their lots that now comprise the school site of the Valencia Community School in order that issuance of titles to said lot owners be expedited as early as possible;

RESOLVED FINALLY, to furnish copy of this Resolution each to: the Honorable City Mayor, the City Fiscal, Coun. Porfirio Ayuyao, Mr. Roberto B. Paz (Ormoc II Supervisor), Mr. Andres Garces, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.
