RESOLUTION NO. 157

WHEREAS, Major Ciriaco Porcadilla is unwilling to vacate his position as Chief of Police, this city, and that Councilor Cleto P. Evangelista maintained that his (Major Porcadilla's) appointment has been confirmed by the Commission on Appointments;

WHEREAS, Councilor Alvaro I. Gutierrez, in order to clear things out regarding the position of Chief of Police of Ormoc City, suggested that a telegram of inquiry be sent to His Excellency, the President of the Philippines with request to send his reply by wire, as to who is the rightful Chief of Police of Ormoc City;

NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved, to send a telegram of inquiry to His Excellency, the President of the Philippines as to who is the rightful Chief of Police of Ormoc City;

RESOLVED FURTHER, that His Excellency, the President of the Philippines be requested to send his reply by wire;

RESOLVED FINALLY, to furnish copy of this resolution each to His Excellency, the President of the Philippines, Malacañang, Manila; the Hon. Executive Secretary, Manila; the Hon. City Mayor; the City Treasurer, the City Auditor, the Chief of Police, all of Ormoc City.
