RESOLUTION NO. 167

WHEREAS, during the hospitalization and treatment of said Policeman Edilberto Jamile, Dr. Cesar Samson, his attending Physician, claimed to have incurred expenses in the amount of P187.00 as listed by item in his letter; and

WHEREAS, said Policeman got his illness in line of duty;


NOW, THEREFORE, the Board, on motion of Councilor Teotimo Ocubillo seconded by Councilor Jorge S. Tan;

BE IT RESOLVED as is hereby resolved to appropriate the amount of P187 to be taken from the salary savings of the Police Department in the current appropriation for the hospitalization and treatment expenses of policeman Edilberto Jamile, from October 25, 1955 to November 14, 1955 in accordance with the claim of Dr. Cesar Samson, his attending physician.
