In conformity with the ordinance on Sanitation in  
the Public Market, this City, it is requested that an  
appropriation be created by this honorable body for the  
following:

- (a) Purchase of/<sup>a</sup>fifteen (15) yard water hose  
1/2 inch with nozzle for cleaning purposes.
- (b) Boring of holes in every fish box (Pasong)  
for draining purposes.

It has been noted that in every box mentioned in  
(b) above, water can not be drained out properly hence  
cleaning of same is made inconvenient.

1956 fiscal budget;




