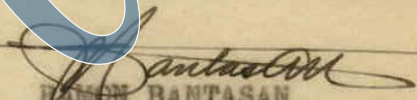
NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos seconded by Councilor Jorge S. Tan,

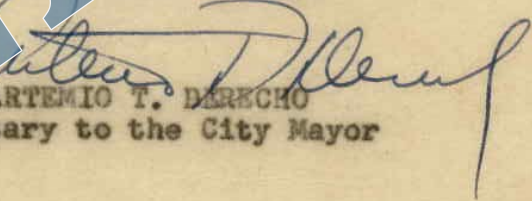
