RESOLUTION NO. 171

WHEREAS, a claim has been presented in the Office of the City Engineer, Ormoc City, by the Western Leyte College, represented by Mr. Felipe Adolfo, for the payment of the portion of land owned by said college which was affected in the widening and opening of Bonifacio Street of Ormoc City;

WHEREAS, a Road Right-of-Way agreement was executed between the Government of the Philippines, represented by the City Engineer, and the land owner, claimant, as above stated;

WHEREAS, the Appraisal Committee of Ormoc City, composed of the City Treasurer as chairman, the City Auditor and the City Engineer as members, actually inspected said lot containing an area of 212.90 square meters, affected by the opening and widening of Bonifacio Street, Ormoc City; and

WHEREAS, said Appraisal Committee of Ormoc City, in its regular meeting held in the Office of the City Treasurer on September 9, 1954, unanimously approved a resolution numbered 1, appraising said lot at ₱3.50 per square meter, taking into consideration the existing assessment rate and the owner is benefited by the extension of the road due to the increase in the market value;

NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved to concur with Resolution No. 1, series of 1954, of the Appraisal Committee, this city, and approving the amount it stated in said Resolution of that Body, in order to help defray the income tax obligations of the Western Leyte College as per request.

RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer, the Appraisal Committee, the Director, Western Leyte College, all of Ormoc City.


