RESOLUTION NO. 172

WHEREAS, the public interest demand the restoration of the services of the Ormoc Telephone System;

WHEREAS, Councilor Jorge S. Tan, strongly suggested the imperative necessity for the resumption of said services which would benefit the public in general taking into consideration untoward incidents and public calamities that may occur from time to time;

WHEREAS, Mr. Jose Leuterio, showing before this Honorable Body the articles of co-partnership claims that he is a co-partner and at the same time manager of the Ormoc Telephone System;

WHEREAS, Councilor Jorge S. Tan manifested that the only way for the present to benefit the services of the Ormoc Telephone System is to request Mr. Jose Leuterio, co-partner and at the same time manager of said Telephone System to restore the services of said System as soon as possible for the good of the demanding public;

NOW, THEREFORE, the Board on motion of Councilor Jorge S. Tan, seconded by Councilor Esteban C. Conejos;

BE IT RESOLVED, as is hereby resolved, to respectfully request Mr. Jose Leuterio, co-partner and at the same time manager of the Ormoc Telephone System, to restore to the public the services of the Ormoc Telephone System;

RESOLVED FURTHER, that the Honorable City Mayor be respectfully requested to extend police protection to Mr. Jose Leuterio, co-partner and at the same time manager of the Ormoc Telephone System when necessity demands;


RESOLVED FINALLY, to furnish copy of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the Chief of Police, Mrs. Edilberta M. Tandayag, Mrs. Feliza Z. Mejia, Mr. Jose Leuterio, all of Ormoc City, to Mr. Angel Veloso, Baybay, Leyte, and to Congressman Domingo Veloso, House of Representatives, Manila.


