RESOLUTION NO. 174

WHEREAS, the City of Ormoc has been regularly receiving issues of magazines, newspapers and books allocated for the City Public Library;

WHEREAS, the proposed inauguration of the City Public Library was set as of the first week of July, 1955;

WHEREAS, because of the space which the city could not up to now provide for such library, in view of the delay in the completion of the construction of the building in which said library would be housed, inauguration of same could not be effected as scheduled; and

WHEREAS, according to Mrs. Norberta P. Martillo, Librarian for the Leyte Branch Library at Tacloban City, had been instructed by the Director of Public Libraries to withdraw the library books that have been allocated to Ormoc City, because of the city's failure to effect the inauguration of the library as scheduled;

NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla seconded by Councilors Esteban C. Conejos and Porfirio Ayuyao;

BE IT RESOLVED, as is hereby resolved, to request Mrs. Norberta P. Martillo, Leyte Provincial Librarian, to withhold action regarding the withdrawal of books to the National Library until the City Engineer tells this Body definitely when he can give a decent room for the proposed Ormoc City Library.

RESOLVED FINALLY, to furnish copies of this Resolution each to the Director of Public Libraries, Manila; to Mrs. Norberta P. Martillo, Leyte Provincial Librarian, Tacloban City; to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.
