RESOLUTION NO. 177

Memorandum Circular from the Office of the President of the Philippines dated June 27, 1955, quoted verbatim hereunder, follows:

"OFFICE OF THE PRESIDENT OF THE PHILIPPINES

"MEMORANDUM CIRCULAR

"TO ALL SECRETARIES OF DEPARTMENTS, HEADS OF BUREAUS, OFFICES AND GOVERNMENT OWNED AND CONTROLLED CORPORATIONS, AND PROVINCIAL GOVERNORS AND CITY MAYORS:

"For the information and guidance of all concerned, the pictures 18" x 24", four-color lithograph printed in the U.S.A. of oil portraits, of the President and the Vice-President may be obtained from the stock of the Bureau of Supply at ₱1.20 each or ₱2.40 a set.

"The usual requisitions for the pictures mentioned above may be sent direct to the Bureau of Supply.

"This supersedes Memorandum Circular dated December 2, 1954, of this Office, concerning the same subject matter. All requisitions for these pictures previously sent thru this Office have been transmitted to the Bureau of Supply accordingly.

"Provincial Governors are requested to transmit the contents hereof all municipal and municipal district mayors under their jurisdiction.

"Compliance with this Memorandum Circular is enjoined.

RESOLUTION NO. 177, s. 1955 - con'd.



CARRIED UNANIMOUSLY.


