RESOLUTION NO. 180

WHEREAS, the Court of First Instance now stationed
in the City of Ormoc is not furnished with tables and
chairs for the use of the personnel therein;

WHEREAS, the City of Ormoc loaned to said Court
of First Instance four tables and five revolving chairs
belonging to the Municipal Board, which until now is
still used by said court;

WHEREAS, inasmuch as the assumption of the newly
elected City Councilors of Ormoc on January 1, 1956 is
drawing near, the Municipal Board would be badly in
need of those tables and chairs for the new City Coun-
cilors;

WHEREAS, for respect and high regards to said Court
the Municipal Board of Ormoc City could not possibly
get back those tables and chairs leaving the court un-
furnished with these equipments; and

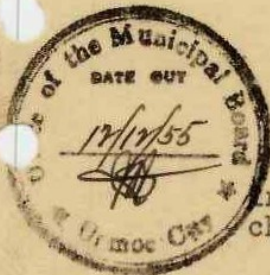
WHEREAS, according to law, said court is to be
maintained by the provincial government of Leyte; and

WHEREAS, according to the Clerk of said Court he
has already filed a requisition with the provincial
treasurer of Leyte which until is not yet supplied;

NOW, THEREFORE, the Board, on motion of Councilor
Guillermo T. Parrilla seconded by Councilor Teotimo
Ocubillo;

BE IT RESOLVED, as is hereby resolved, to request
the provincial government of Leyte, thru the Provincial
Governor, to appropriate the necessary funds with which
to purchase the equipments of the Court of First In-
stance now stationed in Ormoc City, to replace the eq-
uipments recently borrowed by that Court from the City
of Ormoc for the reason that the City needs all those
equipments very badly;

RESOLVED FINALLY, to furnish copies of this Reso-
lution each to the Honorable Bernardo Torres, Provin-
cial Governor of Leyte, Tacloban City; the Clerk of the
Court of First Instance stationed at Ormoc City; the
Honorable City Mayor, the City Treasurer, the City
Auditor, all of Ormoc City.


