RESOLUTION NO. 182

WHEREAS, the amount of P4,000 has been set aside
by the National Government for the construction of
Simangan Primary School;

WHEREAS, said school can not be constructed on
a school site not owned by the government;

WHEREAS, the government does not own any lot in
Barrio Simangan wherein said school can be constructed;
and

WHEREAS, Councilor Jorge S. Tan of Ormoc City, in
an act of liberality and generosity, donated a portion
of his land situated at Simangan, Ormoc City, particu-
larly described as Lot No. 4486-C, with an area of 5,000
square meters more or less for the construction of the
Barrio School in Simangan; and

WHEREAS, in the deed of donation executed by Coun-
cilor Jorge S. Tan on December 21, 1955, the Honorable
City Mayor, Potenciano A. Larrazabal has been the DONEE
representing the City Government of Ormoc;

NOW, THEREFORE, the Board, on motion of Councilor
Teotimo Ocubillo seconded by Councilor Esteban C. Conejos;

BE IT RESOLVED, as is hereby resolved, to authorize
the Honorable City Mayor of Ormoc to accept the donation
of Councilor Jorge S. Tan of 5,000 square meters of his
land in Simangan, Ormoc City, for school purposes of that
barrio;

RESOLVED, FINALLY, to furnish copies of this Reso-
lution each to the Honorable City Mayor, the City Treas-
urer, the City Auditor, the City Engineer, the City Sup-
ervisor, District I, all of Ormoc City; the Division
Superintendent of Schools, Tacleban City, the Director
of Public Schools, Manila and Councilor Jorge S. Tan,
Ormoc City.
