constructed in Barrio Simangan, Ormoc City;

WHEREAS, said school needs a decent site wherein  
it should be situated;

WHEREAS, the government does not own any land in  
Barrio Simangan where said school can be constructed on;

WHEREAS, Councillor Jorge S. Tan, in an act of gen-  
erosity, donated to Simangan Barrio School one-half hec-  
tare (5,000) square meters of his land in Simangan for  
the school site of said school;

WHEREAS, one-half hectare is too small a site for  
said school;

NOW, THEREFORE, the Board, on motion of Councillor  
Usualdo F. Laguitan seconded by Councillor Teotimo Oc-  
ubillo;

BE IT RESOLVED, as is hereby resolved, to request  
Atty. Vicente Torres to donate one-half hectare of his  
land in Simangan adjoining the other half of Councillor  
Tan for the school site of Simangan Barrio School;

RESOLVED FURTHER, to authorize and/or request the  
school authorities to initiate a move to negotiate with  
Atty. Vicente Torres about the above-mentioned one-half  
hectare donation;


RESOLVED FINALLY, to furnish copies of this Reso-
