Gutierrez;

BE IT RESOLVED, as is hereby resolved, to direct  
the City Treasurer of Ormoc City, to stop paying the  
salaries of Mr. Menandro J. Tavera as ex-officio city  
assessor effective as of the month of October, this  
year and up to this time;

BE IT RESOLVED FURTHER, that said payment be given  
instead to Atty. Rafael D. Omega who is now acting as  
City Treasurer of Ormoc, since October, 1955;

RESOLVED FINALLY, to furnish copies of this Reso-  
lution each to the Honorable City Mayor, the City  
Treasurer and the City Auditor, all of Ormoc City.
