RESOLUTION NO. 16

WHEREAS, this Body, in its Resolution No. 160, series of 1955, copies furnished all department heads of Ormoc City, requested that should any department head go out of the City of Ormoc they should inform the Honorable City Mayor or the Secretary of the Municipal Board;

WHEREAS, in spite of the aforesaid resolution, Engineer Montes of Ormoc City has been repeatedly going out of the City of Ormoc without giving notice to the Honorable City Mayor or the Secretary of the Municipal Board; and

WHEREAS, the travels of Engineer Montes being paid by a counterpart fund of the City of Ormoc, the Honorable City Mayor as Chief Executive of the City should be entitled to know of his whereabouts;

NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Teotimo Ocubillo;

BE IT RESOLVED, as is hereby resolved, to direct the City Treasurer of Ormoc City to stop paying the per diems of Engineer Montes, including his traveling expenses, when going outside the City of Ormoc, unless he gives notice to the Honorable City Mayor or the Secretary of the Board pursuant to Resolution No. 160, series of 1955 and; unless his travels are urgent and official in nature or when called by higher authorities in Manila;

BE IT RESOLVED FURTHER, that this resolution be applicable to Mr. Eugenio Cresencio of the Engineering Department, Ormoc City, in the same manner;

RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.
