RESOLUTION NO. 19-A

WHEREAS, Judge Cesar Gonzales has served as Municipal Judge of Ormoc City for the period from July 17, 1952 to May 14, 1953, inclusive;

WHEREAS, serving in such capacity, he was paid by the city government of Ormoc a salary of ₱210.00 a month which is 70% of ₱300.00, in accordance with Republic Act 179, otherwise known as the Charter of Ormoc City;

WHEREAS, with the passage of Republic Act 840, the Municipal Judge of Ormoc City is entitled to receive a salary of ₱245.00 (70% of ₱350), thereby leaving an accruable balance in favor of Judge Cesar Gonzales in the amount of ₱35.00 per month or a total of about ₱350.00 more or less covering the period of ten months from July 17, 1952 to May 14, 1953;

NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Emilio C. Penserga;

BE IT RESOLVED, as is hereby resolved, to appropriate the sum of THREE HUNDRED FIFTY PESOS (₱350.00) from out of any funds existing in the City Treasury not otherwise appropriated, to be made available for the payment of the differential pay of Judge Cesar Gonzales;

RESOLVED FURTHER, to authorize the City Treasurer of Ormoc City to pay to Judge Cesar Gonzales his salary difference as contemplated above, which is an outstanding preferential obligation of Ormoc City;

RESOLVED FURTHERMORE, to incorporate the sum of ₱350.00 as above appropriated, in the current fiscal budget for the general fund of Ormoc City;

RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and Judge Cesar Gonzales, all of Ormoc City.
