RESOLUTION NO. 23

WHEREAS, with the abolition of the Deputy Chief of Police, Police Department, Ormoc City, the Chief of Police is the sole senior officer to take charge of said department;

WHEREAS, without a junior officer to take charge of said police department in the absence of the Chief of Police, it would be impossible for said department to function smoothly;

WHEREAS, on manifestations of Councilor Inaki Larrazabal to create a position for Assistant Chief of Police in the Police Department of Ormoc City, to take the place and/or be in charge of the Police department in the absence of the Chief of Police;

NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Teotimo P. Ocubillo;

BE IT RESOLVED, as is hereby resolved, to create the position of Assistant Chief of Police in the Police Department, Ormoc City, with a brevet rank of first lieutenant if he is not himself a lieutenant or a reserved lieutenant in the army;

RESOLVED FURTHER, that the position of Assistant Chief of Police as is hereby created, shall be provided for a compensation at the rate of ₱1800 per annum;

RESOLVED FURTHERMORE, to incorporate this position above created in the current fiscal budget of Ormoc City;

RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Executive Secretary, Malacañang, Manila; to the Honorable City Mayor, the City Treasurer, the City Auditor and the Chief of Police, all of Ormoc City.
