RESOLUTION NO. 25

WHEREAS, the City Government of Ormoc is maintaining three clerks and a janitor in the office of the District Supervisor of Ormoc District I with Central Office at the Ormoc Elementary School;

WHEREAS, there are two supervisory districts in Ormoc City, the other one being the Ormoc II District with Central School and office at Valencia;

WHEREAS, these two supervisory districts of Ormoc City are of the same category, responsibility and practically of the same aspects with regards to school matters;

WHEREAS, while the city government of Ormoc is paying four office personnel in the central school of Ormoc I, there is none in Ormoc II;

WHEREAS, Mr. Roberto Paz, District Supervisor of Ormoc II District earnestly requested this Body to provide the central school of Ormoc II at Valencia one janitor to help maintain the cleanliness of the school grounds of his central school;

NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Esteban Conejos;

BE IT RESOLVED, as is hereby resolved, to create one (1) position for janitor-clerk in the Office of the District Supervisor, Ormoc II District, Ormoc City, with compensation at the rate of ₱960.00 per annum;

RESOLVED FINALLY, to furnish copies of this Resolution each to the Division Superintendent of Schools, Tacloban City; the District Supervisor, Ormoc II District, the Honorable City Mayor, the City Treasurer, and the city Auditor, all of Ormoc City.
