WHEREAS, Resolution No. 96, s. 1955 of this Body
unanimously approved and appropriated the sum of P500

WHEREAS, Mr. Ramon Bantasan made representations
to this Body that he is in dire need of money at pre-
sent for the expenses of his son studying in Manila;

ary difference in the amount of P1061.91;

NOW, THEREFORE, the Board, on motion of Councilor

Conejos;

BE IT RESOLVED, as is hereby resolved, to appro-
priate the sum of P600.00 from out of any funds exist-
ing in the city treasury not otherwise appropriated,
to be made available for the partial payment of Mr.
Ramon Bantasan's salary difference of P1061.91;

RESOLVED FURTHER, to authorize the City Treasurer
of Ormoc City to pay to Mr. Ramon Bantasan the amount
P600 representing a partial payment of his salary dif-
ference, as above contemplated;

RESOLVED FURTHERMORE, to incorporate the sum of
P600 as above appropriated, in the current fiscal
budget for the general fund of Ormoc City;

RESOLVED FINALLY, to furnish copies of this Reso-
lution each to the Honorable City Mayor, the City Treas-
urer, the City Auditor and Mr. Ramon Bantasan, all of
Ormoc City.
