WHEREAS, in said communication of the City Auditor, he asked this Body to appropriate the amount of P800.00 in functional account C-3-c for the wages of two daily laborers which he desires to employ temporarily;

NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilors Alvaro I. Gutierrez and Inaki Larrazabal;

BE IT RESOLVED, as is hereby resolved, to appropriate the amount of P800.00 in functional account C-3-c for the wages of two laborers on daily basis, in the office of the City Auditor, Ormoc City;

RESOLVED FURTHER, that the amount above appropriated shall be taken from any funds existing in the City Treasury not otherwise appropriated, the same be incorporated in the current fiscal budget for the general fund of Ormoc City;

RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer and City Auditor, all of Ormoc City.
