RESOLUTION NO. 36

WHEREAS, the salaries of some of the intermediate teachers in Ormoc City District I have already been adjusted or standardized; and

WHEREAS, other intermediate teachers who are also entitled to the same privilege and benefit, their salaries remain unadjusted; and

WHEREAS, according to Mr. Leonardo D. Torredes, District Supervisor of Ormoc I, salary adjustments of some of these intermediate teachers are coming from the salary savings;

WHEREAS, Councilor Guillermo T. Parrilla reminded District Supervisor Leonardo L. Torredes that disbursements of city funds like salary savings require the authority of the Municipal Board; and

WHEREAS, payments for salary adjustments of intermediate teachers from the salary savings have not been authorized by the Municipal Board nor are these items provided for or incorporated in the current fiscal budget;

NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Coun. Iñaki Larrazabal;

BE IT RESOLVED, as is hereby resolved, to question the authority of District Supervisor Leonardo L. Torredes to recommend the adjustment of salaries of intermediate teachers in Ormoc from out of the salary savings;

RESOLVED FURTHER, to request the City Treasurer of Ormoc City to stop immediately payments of salary adjustments of intermediate teachers coming from salary savings;

RESOLVED FINALLY, to furnish copies of this Resolution each to the Division Superintendent of Schools, Tacloban City; the District Supervisor, Ormoc I District, the Honorable City Mayor, the City Treasurer, and the City Auditor, all of Ormoc City.


