RESOLUTION NO. 51

"WHEREAS, it has come to the knowledge of this Body that on January 12, 1956, Vice Mayor Rafael M. Mejia collected from the City Treasurer of Ormoc City the amount of ₱260 allegedly as salary for a certain special agent; and

"WHEREAS, this Body doubts the legality of the disbursement of the aforestated amount due to the fact that according to the City Mayor who is the Presiding Officer of this Body, he has never appointed a special agent, nor this Body ever had authorized payment of salaries of special agents from the discretionary fund of the Mayor wherein the aforementioned amount was charged; and

"WHEREAS, in order that this Body will be more enlightened on this matter Councilor Parrilla suggested to indorse this case to the City Attorney for further study, verification and for proper action;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Esteban C. Conejos;

"BE IT RESOLVED, as is hereby resolved, to indorse this matter to the office of the City Attorney for study and verification and for proper action if some irregularities may be found on the matter;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Attorney, all of Ormoc City.
