RESOLUTION NO. 52

"WHEREAS, Mr. Francisco William informed this Body of an anomaly committed by the City Engineer of Ormoc City in 1952 by paying to a road right-of-way claim of one, Arcadia Cabiling, the land claimed supposedly owned by the Government;

"WHEREAS, Mr. Francisco William further informed this Body that the road-right-of-way in question had been paid by the City Treasurer upon authority of the City Engineer in the amount of ₱435 as covered by Voucher No. 825, s. of 1952; and

"WHEREAS, this Body is anxious to verify this anomaly as alleged by Mr. William;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Guillermo T. Parrilla;

"BE IT RESOLVED, as is hereby resolved, to investigate that payment authorized by the City Engineer to Voucher No. 825, series of 1952, in the amount of ₱435 in favor of Arcadia Cabiling, as payment for a road right-of-way claim;

"RESOLVED FURTHER, that the Committee on Public Works be entrusted to conduct the investigation of the payment made on this voucher in question;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, Councilor Iñaki Larrazabal as Chairman of the Committee on Public Works and the Office of the City Engineer, all of Ormoc City;

"CARRIED UNANIMOUSLY."
