RESOLUTION NO. 54

"WHEREAS, this Board, in its Resolution No. 21, current series, requested the Division Superintendent of Schools for Leyte, to assign Mr. Carlos Parrilla, now serving in the Leyte Normal School at Tacloban, as District Supervisor for Ormoc I District;

"WHEREAS, in answer to such request, the Division Superintendent of Schools for Leyte, in his first indorsement dated February 1, 1956, said that Mr. Carlos Parrilla is not qualified to be a district supervisor and to become as such, one should have served as principal for at least two years; and

"WHEREAS, the City of Ormoc needs the services of Mr. Carlos Parrilla;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as is hereby resolved, to petition the Division Superintendent of Schools for Leyte, to reconsider his opinion on his first indorsement dated February 1, 1956, such that the case of Mr. Carlos Parrilla be made an exception to the two years necessary experience as principal before one could qualify as district supervisor, the fact that Mr. Carlos Parrilla is well qualified educationally;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Division Superintendent of Schools, Tacloban City; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."


