RESOLUTION NO. 55

"WHEREAS, former Det. Victor Maglasang of the
Police Force of Ormoc City went to Tacloban City on
January 1, 1954 following an order by the Chief of
Police to arrest an escaped prisoner;

"WHEREAS, in executing Special Order No. 56, s.
1954 of the Police Department of Ormoc City, Former
Det. Victor Maglasang was out of Ormoc City for eight
days and had incurred expenses incidental to his travel;

"WHEREAS, before the closing of the books of ac-
counts during the fiscal year 1953-54, Victor Maglasang
was separated from the service and was unable to collect
the reimbursement of his expenses;


"NOW, THEREFORE, THE Board, on motion of Councilor

to execute special order No. 56, s. 1954;

"CARRIED UNANIMOUSLY."


