BARRIO SITE OF CURVA.

"WHEREAS, the barrio people of curva are anxious to establish a pervanent barrio site - a real property which shall be owned by the barrio;

"WHEREAS, said barrio people of Curva had long been asking the city government of Ormoc to provide for them this with which to settle down themselves peacefully and coundly;

"W. TELES, the city government of Ormoc does not on any land in barrio Curva which will mean to conclude that if this goal is to be attained, either the barrio people or the city government must resort to purchasing if not begging the indulgence or generosity of the land owners in whose lots the barrio people of Curva are now resided; and

"WHEREAS, the City of Ormoc is presently in such a sad plight of her finances that she could barely maintain the routinary expenses of the city, much more for buying a lot for these poor people of Curva;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as is hereby resolved, to request Sra. Alberta Vda. de Martinez and Capt. Canuto Opposa to donate one heactare of land each, situated in Barrio Curva, Ormod City, for a permanent barrio site of Curva;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, Ormoc City; Sra. Alberta Vda. de Martinez, Margen, Ormoc City; Captain Canuto Opposa, Gen. Sepulveda St., Cebu City; the City Treasurer, the City Auditor, the Barrio Lieutenant of Curva, the Principal, Curva Elementary School, all of Ormoc City.
