RESOLUTION NO. 57

"WHEREAS, since the time the City of Ormoc began to exist it has always been a great problem of the city to maintain and finance the intermediate schools of the city;

"WHEREAS, intermediate classes that are now operating and maintained by the city are poorly financed, so much so that the teachers handling these classes are receiving a salary lower than what they are supposed and ought to receive in comparison with teachers handling primary classes maintained by the national government;

"WHEREAS, intermediate teachers of Ormoc City have filed a petition with this Body to request His Excellency, the President of the Philippines to recommend a Bill to congress nationalizing intermediate teachers or intermediate classes of Ormoc City;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilors Emilio C. Penserga and Cesar Samson;

"BE IT RESOLVED, as is hereby resolved, to request His Excellency, President Ramon Magsaysay, to recommend a Bill to congress nationalizing intermediate teachers or classes of Ormoc City; and to request the President further, to recommend an appropriation to the corresponding committee in congress for the purpose;

"RESOLVED FINALLY, to furnish copies of this Resolution each to His Excellency, President Ramon Magsaysay, Malacañang, Manila; the Honorable Secretary of Education, Manila; the Division Superintendent of Schools, Tacloban; the Honorable City Mayor, the City Treasurer, the City Auditor, and the District Supervisors of Ormoc I & II, all of Ormoc City.
