RESOLUTION NO. 58

"WHEREAS, the District Supervisors of Ormoc City have made representations with this Body requesting that the three months back salaries of the city intermediate teachers of Ormoc City be paid before the long vacation this coming April, 1956;

"WHEREAS, the City is presently not in the state of paying all the teachers with their three months back salaries;

"WHEREAS, according to the City Treasurer, the City can afford to pay the teachers only one month of their back salaries;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as is hereby resolved, to authorize the City Treasurer of Ormoc to pay the intermediate teachers of Ormoc City, one month each, of their three months back salaries;

"RESOLVED FURTHER, that because of the urgent need of money with which to defray expenses in undergoing surgical treatment, Mrs. Conrada R. Ababat be paid two months of her three months back salaries;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the District Supervisors, District I & II, all of Ormoc City; the Division Superintendent of Schools, Tacloban City; and Mrs. Conrada R. Ababat, Ormoc City.
