RESOLUTION NO. 60

"WHEREAS, pursuant to the provisions of Sec. 38 of Republic Act 179 as amended by Republic Act 429, otherwise known as the Charter of Ormoc City, there should be a Board of Tax Appeals in Ormoc City which shall be composed of five members to be appointed by the President of the Philippines with the consent of the Commission on Appointments of Congress;

"WHEREAS, the City Treasurer of Ormoc informed this Body of the urgent need for the creation of a Board of Tax Appeals in the City in order to decide on appeals filed by some real property tax payers;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Teotimo P. Ocubillo;


"BE IT RESOLVED, as is hereby resolved, to create a Board of Tax Appeals for Ormoc City, effective upon the qualification of the members thereof;

"RESOLVED FURTHER, to authorize the City Mayor to submit to the President of the Philippines the recommendees for appointment to constitute the members of the Board of Tax Appeals as is hereby created;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the President of the Philippines, Malacañang, Manila; the Honorable Executive Secretary, Malacañang, Manila; the Honorable Secretary of Finance, Manila; the Honorable City Mayor, the City Treasurer, & the City Auditor, all of Ormoc City.

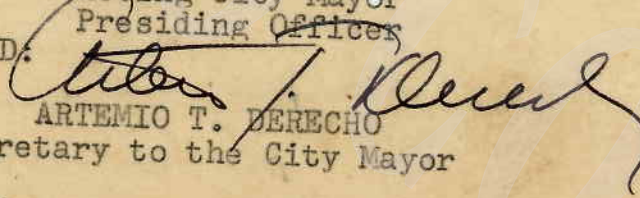
