RESOLUTION NO. 65

"WHEREAS, it is a known fact that the Ornoc Electric Company is operating on a franchise;

"WHEREAS, as a public utility the operation of the company comes under the jurisdiction of the Public Service Commission;

"WHEREAS, as a public utility, the Ormoc Electric Company is supposed to give satisfactory service to the public;

Tested lefore this Body that the Ormoc Electric Company is siving out a voltage on its lines as low as 100 to 160 volts instead of the 220 volts that they are supposed to power their lines;

WHEREAS, because of flactuations in the current given out by the company several consumers have complained of their fuses burning out quite often;

*WHEREAS, the rate at which the Ormoc Electric Company is charging the people of Ormoc City for the consumption of electric current is one among the few companies throughout the country charging the most exhorbitant rates (\$\mathbb{P}0.40\$ per kwh);

"WHEREAS, on manifestation of Councilor Jorge
P. Tan Jr. to call the attention of the Ormoc Electric
Company of the poor service they are giving to the
public and that the company be requested to install
a device to regulate the voltage in order that voltage
on the consumers' lines should not flactuate;

"NOW, THEREFORE, the Board, on motion of Councilor Jorge P. Tan Jr., seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as is hereby resolved, to call the attention of the Ormoc Electric Company of the poor service they are giving to the public and to request the company to install a device which will regulate the voltage in order that voltage on the consumer's lines will not flactuate;

"BE IT RESOLVED FURTHER, to request the Ormoc Electric Company to reduce the present rates at which they are charging the people of Ormoc City for the consumption of electric current;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Public Service Commission, Manila; Aboitiz & Co., Inc., Juan Luna St., Cebu City; the Honorable City Mayor, the City Treasurer, the City Auditor, Aboitiz & Co., Inc. (Ormoc Electric Company), all of Ormoc City.
