RESOLUTION NO. 68

A RESOLUTION AUTHORIZING THE CITY TREASURER OF
ORMOC CITY TO PAY THE SALARIES OF MR. PASTOR
TAN PENDING RECEIPT OF THE AUTHORITY FROM
MALACANANG

"WHEREAS, Mr. Pastor Tan had been serving as
Bookkeeper in the Office of the City Treasurer of
Ormoc City, having been employed in lieu of Marcos
Pirante who has been retired by virtue of Republic
Act 660;

"WHEREAS, pursuant to existing laws the employ-
ment of Mr. Pastor Tan in a vacated position by vir-
tue of retirement of the former incumbent, requires
the authority of the President of the Philippines;

"WHEREAS, Mrs. Pastor Tan made representations
with this Body requesting that he be paid of his sal-
aries pending the receipt of the authority from Mala-
cañang;


"NOW, THEREFORE, the Board, on motion of Coun-

the authority from Malacañang;


"RESOLVED FINALLY, to furnish copies of this
