RESOLUTION NO. 71-A

"WHEREAS, Councilor Esteban C. Conejos of Ormoc City is going to Manila to follow up important business of the City of Ormoc now pending in the different bureaus and offices in Manila;

"WHEREAS, some of these important business now pending in their corresponding bureaus and offices are the following:

1. Request of the City Government of Ormoc for a \$100,000 loan for the construction of a bigger market;
2. Requesting the Honorable Secretary of Education to consider the payment of salary differentials of intermediate teachers of Ormoc City;
3. Requesting His Excellency, the President of the Philippines to recommend a Bill to Congress nationalizing the City Intermediate Teachers of Ormoc;
4. Petition of some barrio people of Ormoc requesting the President of the Philippines to allocate for their barrio a prefabricated school building (Linao & Catmon); and others;

"NOW, THEREFORE, the Board, on motion of Councilor Iñaki Larrazabal, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as is hereby resolved, to authorize Councilor Esteban C. Conejos, as he is hereby authorized, to make representations in the different departments, bureaus and offices in Manila, where an important business for the interest of Ormoc City may be found;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and Councilor Esteban C. Conejos, all of Ormoc City.
