"WHEREAS, said damaged crop is all valued at ₱140;

"WHEREAS, for the use of this lot occupied by the airstrip the City of Ormoc has fixed with the lot owner, Mr. Antonio B. Tan, its rental at ₱80.00 per annum;


NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Jorge P. Tan, Jr,


