RESOLUTION NO. 75

"WHEREAS, the City of Ormoc is in receipt of her share from the Philippine Charity Sweepstakes draw held on December 18, 1955 in the amount of ₱318.90 as covered by Check No. PC-01196;

"WHEREAS, as provided by law, this share may be allotted by the Municipal Board for maintenance of city health, social welfare and charitable work based upon the recommendation of the chief of the health department;

"WHEREAS, the City Health Officer, in a 2nd indorsement dated March 7, 1956 recommended that this amount of ₱318.90 be allotted as follows:

₱200 - for the salary of the dental attendant;
₱118.90 - for repairs of the public dispensary building;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as is hereby resolved, to appropriate the share of Ormoc City from the Philippine Charity Sweepstakes draw of December 18, 1955 in the amount of ₱318.90 covered by Check No. PC-01196 for the following:

₱200 - be applied for the salary of the dental attendant in the city health office;
₱118.90 - for repairs of the public dispensary building;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Health Officer, all of Ormoc City.
