"WHEREAS, this Board finds that the ferry service operated by the aforementioned applicant is commendable, the same having been operated efficiently to the satisfaction of the public;


"NOW, THEREFORE, the Board, on motion of Councilor Iñaki Larrazabal, seconded by Councilor Alvaro I. Gutierrez;



"CARRIED UNANIMOUSLY."


