RESOLUTION NO. 78

Resolution No. 2340, series of 1955, of the City Council of Basilan, requesting His Excellency, the President of the Philippines, to reverse the opinion of the Assistant Executive Secretary, dated May 3, 1955, in interpreting paragraph 4 of Executive Order No. 31, s. of 1954, of the President, in such a manner as to include the members of the Provincial Board and of City Councils or City Boards as officials of equal rank to that of the Provincial Governor, Treasurer, Auditor, etc., for the reasons stated therein, was presented.

On motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere with Resolution No. 2340, series of 1955, of the City Council of Basilan and to request His Excellency, the President of the Philippines, to reverse the opinion of the Assistant Executive Secretary, dated May 3, 1955, in interpreting paragraph 4 of Executive Order No. 31, s. of 1954, of the President, in such a manner as to include the members of the Provincial Board and of City Councils or City Boards as officials of equal rank to that of the Provincial Governor, Treasurer, Auditor, etc., and the Secretary of the Provincial Board, City Council or Municipal or City Board;


"RESOLVED FINALLY, to furnish copies of this Resolutions each to the Honorable Executive Secretary, Malacañang, Manila; the Honorable City Mayor, the City Treasurer, the City Auditor; all of Ormoc; the City Council, City of Basilan and the Leyte Provincial Board, Tacloban City.


