RESOLUTION NO. 50

"WHEREAS, Resolution No. 56, c.s. of this Board, requested, among others, Sra. Alberta Vda. de Martinez to donate one (1) hectare of land in Barrio Curva, Ormoc City, to be made the permanent barrio site;

"WHEREAS, Sra. Alberta Vda. de Martinez in her letter to the Board dated March 21, 1956 voiced her refusal to accede to the request contained in Resolution No. 56, c.s. for reasons stated in said communication;

"WHEREAS, the Board has come to the conclusion that it is only the land of the Martinezes that is most appropriate to be used as permanent barrio site of Curva;

"WHEREAS, the people of Barrio Curva and the Board have never doubted the generosity and kindness of Sra. Alberta Vda. de Martinez, especially in matters where the needs of the barrio people is concerned;

"WHEREAS, in the event the donation is materialized, the Board will work out to change the name of "Barrio Curva" to "Barrio San Rafael" (or a combination of the donors' names, as the case maybe), to honor and perpetuate the name and memory of the late Don Rafael Martinez;

"NOW, THEREFORE, the Board, on motion of Vice Mayor Rafael M. Mejia, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as is hereby resolved, to request Sra. Alberta Vda. de Martinez to reconsider her answer to Resolution No. 56, c.s. of this Board, and to reiterate the request of this Board as contained in said Resolution No. 56, current series;

"RESOLVED FINALLY, to furnish copies of this Resolution each the Honorable City Mayor, the City Treasurer, the City Auditor, Sra. Alberta Vda. de Martinez, Margen, and the Barrio Teniente of Curva, all of Ormoc City.
